OBJECTIVE

The Guinness China RMB Income Fund aims to provide investors with a combination of capital appreciation and income. The Fund invests in a range of bonds and fixed income investments which will be denominated or hedged back to Renminbi (Renminbi or RMB being the official currency of China). The Fund buys government and quasi-sovereign bonds in the onshore China bond market and supranational and high-grade corporate credit in the offshore bond market. The Fund is actively managed without reference to a benchmark.

COMMENTARY

China's economy is exhibiting a "two-speed" recovery, with a notable disconnect between resilient state-backed industry and weak household demand. The recent surge in industrial profits (up 20.4% year-on-year) and the slight firming of the producer price index confirm that the government's targeted support for large, upstream manufacturing sectors (part of the "anti-involution" drive) is successfully boosting corporate margins and output. This effort is focused on achieving qualitative growth in advanced manufacturing. Concurrently, strengthening trade with Southeast Asia is providing a structural hedge against US trade tensions, reflecting deepening regional supply chain integration and stability in China's external performance.

However, the key drag remains domestic consumption. Disappointing retail sales and a persistent slump in the real estate sector highlight severely constrained household confidence. While the People's Bank of China (PBoC) has held its key lending rate, indicating a cautious monetary stance, the government has signalled a commitment to boosting consumption through targeted measures, such as new funding for the consumer goods trade-in programme.

PORTFOLIO REVIEW

The Fund's CNH Y class gained +0.21% in Q3'25. The USD Abu Dhabi Government bond, maturing in 2028 was the star performer, with China Government holdings and USD QNB 1.625% 2025 also contributing to positive performance.

In July the CGB 2.2% 2025s matured, we added the CGB 2.39% 2029 issue, and the small cash position was used to add CGB 1.8% 2028. The First Abu Dhabi Bank 3.4% issue matured in August, proceeds were reinvested in the Agricultural Bank of China 2.8% maturing in 2027. Then in September the USD QNB 1.625% bond matured, we invested in a quasi-sovereign green bond issued by the Saudi PIF, GACI 5% 2027. The bond closed the month at yield of 4.25%.

The yield on the 2-year benchmark China Government bond rose 7bps to 1.43%. The onshore and offshore renminbi returned +1.18% and +0.84%, respectively, against the dollar. Against the euro, the currencies returned +1.23% and +0.89%, respectively. The A1 (weighted average rating factor) rated portfolio yields 1.72% and has a duration of 1.62 years.

OUTLOOK

The near-term outlook is critically dependent on the acceleration of policy stimulus to counteract weak domestic demand and stabilise the property market. We anticipate the government will deploy more aggressive fiscal spending and likely use monetary tools, such as further required reserve ratio and interest rate cuts, to lower financing costs and boost overall liquidity. The PBoC's increased liquidity injection and its stated focus on supporting small and micro enterprises, alongside stabilising foreign trade, underscore the policy urgency to manage growing economic uncertainty.

This trajectory is a committed effort to execute a stable, structural transition to a high-quality growth model. For markets, this suggests that outperformance will be concentrated in sectors directly aligned with state priorities: advanced manufacturing, state-owned-enterprise heavy industries, and beneficiaries of consumption subsidy programmes. While the property downturn is a multi-year headwind, the sustained, targeted support from Beijing is expected to prevent a severe slowdown and deliver uneven but managed sequential growth, with policy-backed sectors leading the performance.

The renminbi's outlook is positive, with a strategic shift toward managed appreciation. This move signals Beijing's confidence in its economic recovery and its efforts to combat deflation, while also attracting foreign investment and stabilising trade relations with the US

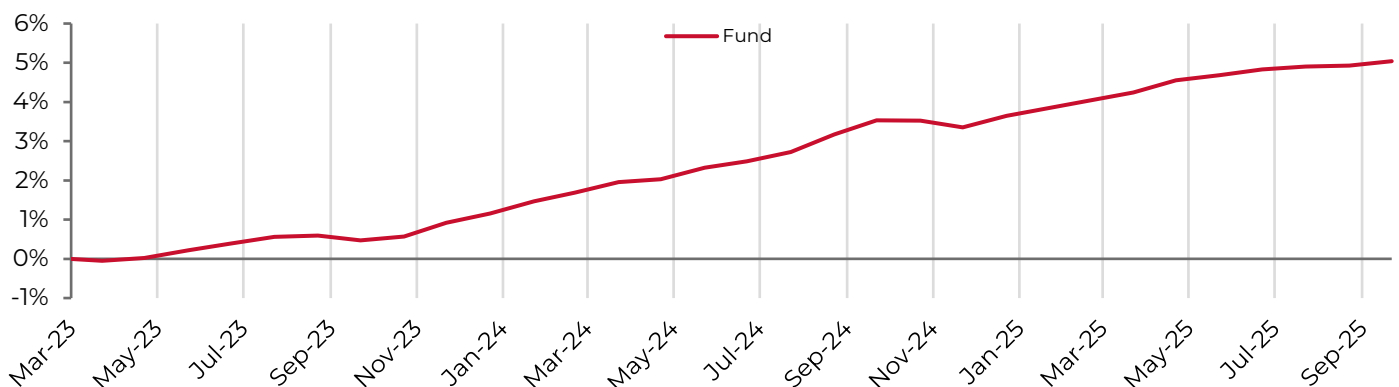
