Aim

Investment Case

Invests in companies providing environmental solutions which contribute to reducing environmental resource use or intensity, and enhancing environmental resource supply. The environmental resources targeted are food, water, climate, waste, and land, and their adjacent supply chains.

Process

The investment process incorporates both top-down and bottom-up considerations to select high-quality companies exposed to the environment theme.

Portfolio

Concentrated, broadly equally-weighted portfolio of 30 positions. Majority of Fund invested in stocks over \$500m in size.

Investment Objective

An equity Fund which invests in companies actively engaged in providing environmental solutions, which contribute to reducing environmental resource use or intensity, or to protecting and enhancing environmental resource supply.

The Fund is actively managed and uses the MSCI World Index as a comparator benchmark only.

For the avoidance of doubt, if you decide to invest, you will be buying units/shares in the Fund and will not be investing directly in the underlying assets of the Fund.
