What is this product?

Type	Enterprise Investment Scheme ("EIS")
Objective	To achieve capital growth over the medium term by investing in companies which qualify for Enterprise Investment Scheme tax reliefs. These tend to be high risk but quoted on AIM and AQUIS exchanges.
Intended retail investor	The Product is intended for investors looking for listed shares in small companies as part of their portfolio, who can take on a high level of risk in order to get a higher potential return and who plan to stay invested for the duration of the Product, which is likely to be between 3 and 5 years.
Insurance benefits	The Product is not designed to create insurance benefits and has no particular insurance costs.

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 5 years. The summary risk indicator is a guide to the level of risk this Product compared to other products. It shows how likely it is that the product will lose money because of movements in the market. This Product does not include any protection from future market performance so you could lose some or all of your investment.

We have classified this product as 7 out of 7, which is the highest risk class.

The investment is in an Enterprise Investment Scheme: pursuant to the information memorandum for the Product (the "Information Memorandum") you do not have discretion to cash out your investment early and if the Manufacturer does permit you to transfer it to a third party you may not get back all of your original investment. You may also have to pay significant costs to exit this Product. There is no particular market for investments of this nature and therefore if you find yourself forced to sell this Product this may severely impact any potential sale price.

The following are some of the other risks materially relevant to the Product which are not taken into account in the summary risk indicator:

- The Product does not include any protection from future market performance, exchange rate movements or interest rate movements so you could lose all or some of your investment.
- If the Product is not able to pay you what is owed, you could lose your entire investment.
- The product invests in early stage, unquoted companies which are inherently risky.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

Composition of costs
